Terms & Conditions

1. The Executive Council holds the full rights to accept or reject any membership application. Justification shall be given for any rejected application.
2. All membership renewal (except for life and honorary member) must be done **before 1st of February every year**.
3. For membership that is not renewed after 1st of April without any valid reason, the Executive Council holds the rights to terminate the membership of the said member.
4. Individual/organization who failed to register/renew for the respective calendar year is not allowed to attend the Annual General Meeting (AGM), any KLGA organized/participating events, and have no rights to vote and be voted.
5. For any terminated membership, the individual/organization requires to make a new registration.
